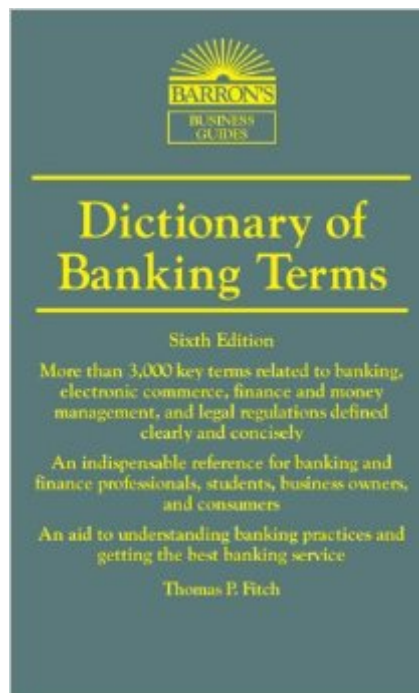

I got a list of every occurrence of the word "Trust" in the entire work. This is hardly a desirable feature for an e-dictionary. You want individual entries, not a huge list of occurrences. I know that Barron's knows how to create an e reference book. They did it right with Dictionary of Finance for Kindle; you can look up the ONE word you want. Barron's, however, failed big time with the Kindle version of Dictionary of Banking Terms.
