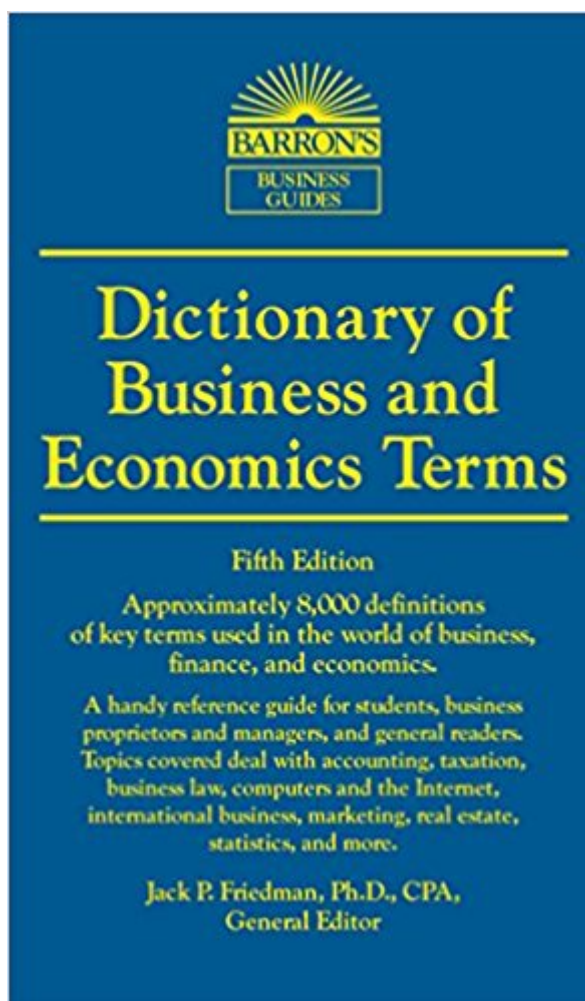

This is a good, general dictionary. I'm in an upper division Macroeconomics course and in the week I've been using this dictionary, I have already identified shortcomings. For example, you can find the definition for the substitution effect (SE) in this dictionary, but it does not distinguish between the SE of a higher real wage vs. SE of the real interest rate in saving. Though this is a good reference for general business and general economics, I will likely purchase an Economics only dictionary to ensure I have all the information I require for Econ coursework.

This one makes sense for just about anyone, whether you are a business student or just need to know a few things dealing with your landlord (that works in the reverse too). As a kindle book, it is a must have because you can find just about anything related to can business and make avoid a complex conversation at say an insurance office or maybe make sure your real estate agent is on the up and up.
