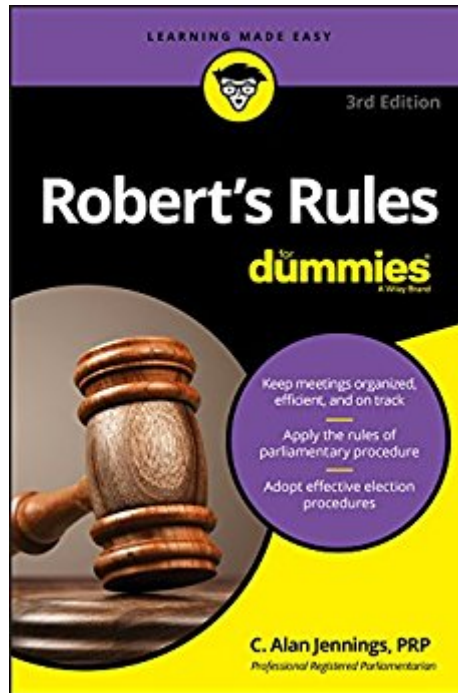

I know because I bought Robert's Rules of Order Newly Revised, 11th edition (Robert's Rules of Order (Paperback)), from . With the aid of the book under review, Robert's Rules For Dummies, the real book makes more sense. Jennings frequently stops to explain WHY a particular rule exists, which I have found more useful than any other feature. If you have been disappointed by the many poorly run meetings you've attended, this book might help you more than the underlying one.

The book covers all the major topics in Robertâ ™s Rules but does so in plain English, with examples and helpful tips, practical advice on when and how to use motions, choose leadership, and conduct meetings, and the reasons why parlimentarians do it this way is more clear in Jenningsâ ™ explanations than if you just read Robertâ ™s Rules, which can be daunting and seem without context. It also addresses these topics in a more logical order than in Robertâ ™s Rules.This book is intended for anyone to wants to â œparticipate more effectively in meetingsâ • or â œto serve in an office to which youâ ™ve recently been elected.â • I wish I had it when I was serving in a community organization and often attended meetings of other local organizations. It is difficult to tease the information you need from Robertâ ™s Rules and to know

what all of your options are. Although this book is not intended to be read cover-to-cover, I did so, and I found it useful to get an overview of all the topics that are covered, so that I can make a note of the most useful procedures. The book is organized into four parts that tackle the procedures for participating in meetings, making motions, choosing leadership, and end with lists of tips and myths. The discussion of making motions is by far the longest, comprising seven chapters.
