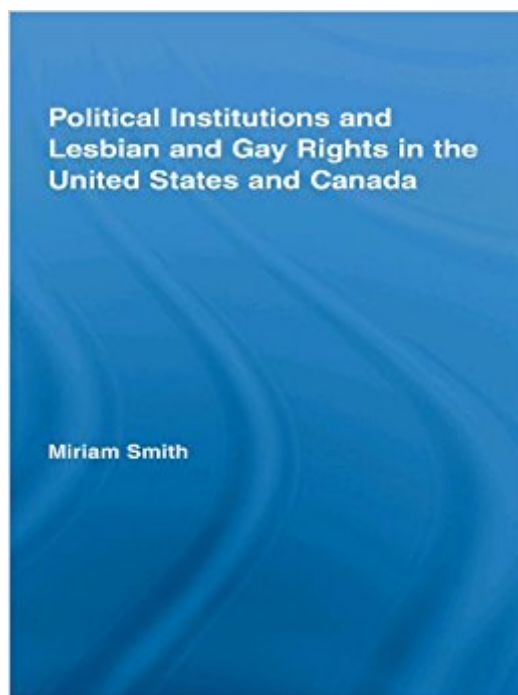

Synopsis

For political science, sociology, and queer studies alike, this book will prove vital as movements for lesbian and gay rights continue to recast the social landscape in North America and beyond.

This book has something for everyone. For those looking for the cutting edge of historical institutional analysis, there is no need to look any farther. For those interested in the comparative politics of lesbian and gay activism, there are profound insights, especially in a policy field that has been largely determined - I would say overdetermined - by cultural studies-type analyses. And for those concerned with the complex questions associated with intersectionality, and how race in particular has played a singular, defining role in how human rights issues are framed or not, this is a particularly gripping read. We need more analyses that position lesbian and gay politics as a proper site of study, especially those anchored in traditional frameworks or approaches such as institutional analysis.
